### **November General Meeting: Learning About Women and Philanthropy**

At our November 12th General Meeting, the program focused on women's growing involvement in philanthropy, and in particular, the recent rapid growth of giving circles. Our inspiring and energizing speakers were Siobhan O'Riordan, an independent consultant formerly with the Washington Area Women's Foundation, and Elise Burke Lee of United Way of Central Maryland and coordinator of their Women's Leadership Council. Both women spoke about how the giving circle model encourages women to become more engaged in learning about philanthropy and smarter about their giving. In addition, the 2009 AAWGT Officer and Steering Committee slate and recommended changes to the AAWGT By-Laws were presented.

In addition, the Grants Committee is getting geared up for the 2009 grants process and will be emailing and mailing notices about available funds to prospective grantees. Grant applications will be due on February 12, 2009 and AAWGT members will vote on funding recommendations at the May 13th General Meeting, which will be announced at the June 10th Grants Showcase. Details, including the grant application, will be posted on the AAWGT website shortly.
